

## **Reach and Teach Campus Tour Contest Rules**

To provide fair and equal chance of winning to all officially enrolled Reach and Teach Campus Tour schools, the following are the official rules.

## NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING.

**Submission:** Episodes should be submitted to <a href="mailto:dustin@reachandteach.rocks">dustin@reachandteach.rocks</a> as a high quality (720p or 1080p) video file in MP4 format. Alternatively, each school will be provided a Google Drive Folder link to upload the final episode file. Each final episode file should be submitted in the following format:

- 1. Episode Intro (with two anchors): 1-2 minutes
- 2. Segment #1 (completely edited): 2-3 minutes
- 3. Segment Transition (with two anchors): 30 seconds 1 minute
- 4. Segment #2 (completely edited): 2-3 minutes
- 5. Segment Transition (with two anchors): 30 seconds 1 minute
- 6. Segment #3 (completely edited): 2-3 minutes
- 7. Segment Transition (with two anchors): 30 seconds 1 minute
- 8. Segment #4 (completely edited): 2-3 minutes
- 9. Episode Outro (with two anchors): 30 seconds 1 minute

The final episode file should be no more than 18 minutes in length.

Reach and Teach intro and transition graphics must be used in the final episode file. Examples of previous Campus Tour episodes can be found at the Reach and Teach website. https://www.reachandteach.rocks/campus-tour

**Restrictions:** Video files submitted must not portray inappropriate, illegal, profane or distasteful activities. Reach and Teach reserves the right to disqualify any submissions based on the content as necessary. Video files cannot include any copyright or trademark material, including but not limited to music, video footage, graphics or logos without proper documentation of consent.

**Deadline:** Each final episode file MUST be submitted by Monday, April 4th at 5:00 pm CST. Any files/footage submitted past this date will not be accepted and the episode will be

disqualified. However, Reach and Teach encourages participating schools to submit episode files as soon as possible. Episodes will be numbered based on the order received.

**Eligibility:** Episodes must be submitted by teachers or representatives of officially enrolled Reach and Teach Campus Tour Schools who are 18 years of age or older. Enrollment is FREE. For more information, visit <a href="www.reachandteach.rocks">www.reachandteach.rocks</a>. All participants featured in the episode must sign the Reach and Teach Media Release Form. Participants who are minors must have the Reach and Teach Media Release Form signed by a parent or guardian. Failure to submit all necessary media release forms to Reach and Teach will deem the episode ineligible and result in disqualification. Each officially enrolled Reach and Teach Campus Tour school has the option to submit more than one episode.

**Original Work:** All files submitted must be original work and considered royalty free. Any use of copyright or trademark material will result in disqualification. Once files are submitted, Reach and Teach has the right to use, distribute and manipulate in any manner. Upon submission, all ownership and rights regarding the files are transferred to Reach and Teach.

**Promotion:** Officially enrolled Reach and Teach Campus Tour schools can begin promoting their episode at any time. Each school will receive their episode link prior to the official premiere date. Reach and Teach is not responsible for promotional efforts regarding each episode. Each officially enrolled Reach and Teach Campus Tour school should determine the most effective promotional strategies regarding their own individual episodes. Reach and Teach encourages schools to use their best judgement when determining promotional strategies to implement. Paid advertisements are acceptable. However, Reach and Teach is not responsible for any expenses incurred by the school throughout the duration of the program.

**Premiere:** In an effort to execute a fair contest, all episodes will premiere on Monday, April 25, 2022 at 7 Eastern/6 Central PM on the Reach and Teach YouTube Channel. Although a link to each episode will be generated and available for promotional use at various times, the episode will not be available for viewing until the official premiere date on April 25, 2022 at 7/6c pm.

Winner: The winner will be determined using the following metrics: 40% total views, 30% technical & creativity rubric, and 30% professional panel review. The premiere window will begin on April 25, 2022 at 7 Eastern/6 Central PM and go through Midnight (Central Time) on May 9, 2022. Access to YouTube Analytic Reports will be available upon request following the conclusion of the contest. In order to be eligible to receive the prize, enrolled schools must adhere to the submission guide provide upon enrollment. Various documents are required to be submitted to Reach and Teach throughout the duration of the project. These documents must be submitted to Reach and Teach in a timely manner. Official winner will be notified via the corresponding teacher's email address provided upon enrollment. Winner notification and announcement will take place on Friday, May 13, 2022. Official winner must be willing to participate in a check presentation ceremony.

**Prize:** The official winner will receive an educational grant from Reach and Teach in the amount of \$1,000. The check will be made payable to the enrolled school of the winning

episode. The grant can be used for classroom supplies, materials or equipment; career tech student organization expenses; educational field trips; and other educational opportunities. The grant cannot be dispersed to any individuals (including students or teachers) for personal use or to non-school affiliated organizations. Claiming of prize requires an email response to Reach and Teach from the winning sender email address within 5 days of being notified of winning at the email address used upon enrollment. Failure to respond shall mean that the winner forfeits the prize.

**YouTube:** Promotion is in no way sponsored, endorsed or administered by, or associated with, YouTube.

**Legalities:** By submitting any video files or information to Reach and Teach, you hereby grant to Reach and Teach and its affiliates, subsidiaries, licensees and assigns, an irrevocable, perpetual and royalty-free right to use, reproduce, edit, display, transmit, prepare derivative works of, modify, publish and otherwise make use of the submitted video files or other information in any and all media, whether now known or hereinafter created, throughout the world and for any purpose. In addition to other things, the rights granted to Reach and Teach includes but is not limited to the right to resize, crop, censor, compress, edit, feature, caption, affix logos to, and to otherwise alter or make use of the submitted video files. By submitting any video files or information to Reach and Teach, you hereby represent and warrant that the submitted video files or information does not and shall not infringe on any copyright, any rights of privacy or publicity of any person, or any other right of any third party, and you have the right to grant any and all rights and licenses granted to Reach and Teach herein, including but not limited to all necessary rights under copyright, free and clear of any claims or encumbrances.

You acknowledge and agree that Reach and Teach shall have no obligation to post, display or otherwise make publicly available any video files or information submitted by you, and may, in its sole and unfettered discretion, remove, edit, modify or delete any video files or information that you submit to Reach and Teach.

You understand and intend that any video files or information submitted by you to Reach and Teach may be available for viewing, rating, review and comment on by the public, and understand that comments or ratings with which you disagree or are unhappy about may be published or otherwise become associated with any video files or information you submit to Reach and Teach. Although Reach and Teach will make every effort to remove any negative or potentially harmful rating, review or comment, by submitting any video files or information to Reach and Teach, you hereby waive any privacy expectations that you may have with respect to any such video files or information submitted by you to Reach and Teach.

You hereby agree to hold Reach and Teach and its affiliates, subsidiaries, licensees sponsors and assignees harmless from and against, and hereby waive any right to pursue, any claims of any nature arising in connection with the inclusion in, publication via or display on any Reach and Teach site, or any other use authorized under these Terms, of any video files or information submitted to Reach and Teach by you.

Photos or information submitted by you shall be the property of Reach and Teach, and Reach and Teach shall have no obligation to preserve, return or otherwise make available to you or others any video files or information so submitted.

Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, whether foreseeable or not and whether based on negligence or otherwise, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this contest), and entrant further waives all rights to have damages multiplied or increased.
